### ACCP Foundation and PPI Merge

"The College," composed of 3 interrelated organizations for the past 30 years, has undergone a structural change. Until recently, ACCP, a 501c6 membership organization, was complemented by two affiliated 501c3 organizations: the ACCP Foundation and Pharmacotherapy Publications, Inc (PPI). As depicted in the accompanying figure, the missions of each entity were unique, yet all 3 organizations contributed to the common mission of improving human health.

In mid-2024, the ACCP Foundation Board of Trustees (BOT) and the PPI Board of Directors (BOD) considered merging their respective 501c3 corporations. Separate board meetings were held where both the ACCP Foundation BOT and the PPI BOD approved plans for merging the ACCP Foundation with PPI and renaming it the ACCP Foundation, Ltd. The transitional board of directors maintains proportionate representation from the Foundation and PPI. Former PPI Board Chair James

Tisdale will now serve as chair of the merged entity, and staff support will be led by Foundation Director Keri Sims, in collaboration with ACCP Associate Executive Director Sheldon Holstad. In addressing the rationale for the merger, Tisdale commented,

Merging the two organizations provides opportunities to unite our respective expertise, eliminate administrative redundancies, and increase the impact of strategic initiatives. It also establishes a more robust organization with increased capabilities that extend beyond those of either entity alone. Consolidation of the boards creates a natural synergy by leveraging our collective perspectives, experience, and resources that we believe will position us to support and disseminate more transformative research, scholarship, and practice.

The new ACCP Foundation, Ltd will focus on generating support for pharmacotherapeutic and clinical pharmacy research, scholarship, and practice advancement;

# **2025 ACCP Virtual Poster Symposium: Call for Abstracts**

### **Important Dates:**

- Submission Deadline
  - March 24, 2025: Submission deadline for Advances in International Clinical Pharmacy Practice, Education or Training, Case Reports, Clinical Pharmacy Forum, Original Research, Scoping Reviews, and Systematic Reviews/ Meta-Analyses abstracts

 April 22, 2025: Submission deadline for Research-in-Progress abstracts (Students and Residents and Fellows)

### Notification of Acceptance

 April 29, 2025: Authors will be notified of acceptance or declination no later than this date.

ACCP invites you to submit an abstract to be considered for presentation during the 2025 ACCP Virtual Poster Symposium (VPS), May 20 and 21, 2025. The VPS was launched in 2012 because travel, funding, and schedule conflicts often made it difficult for participants to attend a conference in person. ACCP continues to host the VPS as an alternative means for individuals to present their research and scholarship to peers and engage in dialogue with colleagues.

All investigators in the field of clinical pharmacy and clinical pharmacology, ACCP members and nonmembers alike, are invited to submit abstracts. There is a \$50 fee to submit an abstract.

The deadline to submit abstracts (EXCLUDING Research-in-Progress abstracts) is March 24, 2025. The deadline to submit abstracts in the Research-in-Progress category is April 22, 2025.

Posters will be on display May 17 through May 25 for asynchronous viewing and comment. In addition, 2 interactive sessions will be held on May 20 and 21, when authors and their virtual posters will be available for real-time online question-and-answer interactions. The technology required for presenters and the poster-viewing audience is minimal—a broadband internet connection and a current version of an internet browser.

### What is the ACCP VPS?

The VPS involves the electronic submission of an abstract. If the abstract is accepted, a poster is created and saved in standard PDF format. The poster is made available for viewing by all attendees during the designated VPS dates. Virtual poster presenters will be virtually present (EITHER May 20 or May 21 from 7 to 9 p.m. [Eastern time]) via an online, real-time chat feature. Presenters also have the option to offer live Q&A via their preferred video/audio platform (eg, Zoom, Teams, Hangouts Meet) during their assigned poster session. Presenters will be able to discuss their findings with students, residents, fellows, seasoned practitioners, and even family and friends during the symposium. Of important note, attendance at the VPS is free. All are invited to attend—ACCP members, colleagues, friends, and family.

All abstracts accepted for presentation, except for "Encore" and "Research-in-Progress" presentations, will

have full-text abstracts published online in *JACCP*. Only the abstract title, authors, and original citation will be published in *JACCP* for "Encore" presentations.

### GTMRx Releases 2024 Summary of Research on the Value of Comprehensive Medication Management

The <u>Get the Medications Right Institute</u> has just released the latest edition of its summary of published research from practice sites using comprehensive medication management (CMM). <u>The Outcomes</u> of <u>Implementing and Integrating Comprehensive</u> <u>Medication Management in Team-Based Care: A Review</u> of the Evidence on Quality, Access and Costs, December 2024, commonly termed the *evidence document*, highlights the best of the studies showing the value of CMM in achieving all 5 aspects of the quintuple aim of health care: providing high-quality care, reducing health care– related costs, improving the patient's care experience, improving health care team members' work-life balance, and achieving health equity.

The 2024 evidence document includes 21 studies, with 5 of the articles published this past year. The new additions include a paper evaluating the impact of CMM on total cost of care in a clinically integrated network that found both lower costs and reduced hospital admissions. A new paper from the Veterans Health Administration documented improvement in the number of patients achieving their diabetes and hypertension goals in clinical practices with greater adherence to the CMM process of care. This edition also features the first report describing the benefits of using CMM to optimize medications in children with complex medical conditions as well as a paper describing implementation of a health equity-informed process to increase recruitment and engagement of patients with hypertension who would benefit from receiving CMM services. As a resource for disseminating the value of CMM, the annual updates of the document continue to reflect the ongoing research in this area and the expansion of CMM into a wider range of practice settings.

The evidence document is a product of the Evidence-Based Resources Subgroup of the GTMRx Practice and Care Delivery Transformation Workgroup. Authors include Shawn McFarland, Pharm.D., FCCP, BCACP; Marcia Buck, Pharm.D., FCCP, FPPA, BCPPS; and Judith Jacobi, Pharm.D., FCCP, MCCM, BCCCP, all members of ACCP. The Practice and Care Delivery Transformation Workgroup, as well as the other GTMRx workgroups, continues to add new members. ### **President's Column** Cheers to Progress and Possibilities in the New Year!

As we kick off 2025, it's a great time to reflect on the past year's victories and look ahead with optimism. In 2024, contrary to the challenges often faced during an election year, ACCP

made remarkable strides in its commitment to advancing clinical pharmacy. Thanks to the leadership of our staff and the unwavering engagement of our members, we've achieved significant milestones that deserve recognition—and **a heartfelt THANK YOU** for your continued support!

Let's take a moment to highlight a few of these accomplishments and the ongoing opportunities where your voice matters.

### ADVOCACY WINS AND INITIATIVES Protecting Residency Funding

This past summer, over 1300 ACCP members joined forces to send more than 2600 letters urging Senate leaders to safeguard pass-through funding for PGY1 (postgraduate year one) residency programs. The bipartisan Rebuild America's Health Care Schools Act (<u>S 5397</u>/<u>HR 10225</u>), championed by Sen Amy Klobuchar (D-MN),

would solidify Medicare support for pharmacy residency programs. ACCP will continue to work with these offices and leaders on the Senate Finance Committee to protect pass-through funds to hospitals for the operation of pharmacy residency programs. Again, thank you for mobilizing to support this critical funding of residency programs. <u>Click here</u> to send a letter to Congress reminding elected officials to act on this important issue.

### SUPPORT Rx Act for Addiction Care

ACCP collaborated with Sen Cory Booker (D-NJ) to develop S 4429, the <u>Substance Use Prevention and</u> <u>Pharmacy Oriented Recovery Treatment Prescription</u> <u>Act (SUPPORT Rx Act)</u>. This act aims to establish pharmacy-based addiction care programs through a 3-year pilot grant. This initiative expands access to lifesaving services provided by clinical pharmacists under collaborative practice agreements. ### Advancing Pharmacogenetic Consultations

After Rep Diana DeGette (D-CO) <u>wrote to ACCP</u> indicating her intention to reintroduce Cures 2.0, she invited ACCP to submit recommendations on the draft proposal. As part of <u>H R 6000, known as "CURES 2.0,"</u> Congress acknowledged clinical pharmacists' key role in delivering pharmacogenetic consultations. This recognition bolsters precision medicine and ensures clinical pharmacists are integral to transformative health care innovations. ### **Addressing Medicare Fee Schedules**

Last fall, ACCP submitted detailed <u>comments</u> to the Centers for Medicare & Medicaid Services urging coverage and payment for medication optimization services delivered by clinical pharmacists. These efforts also emphasized the need to mitigate proposed cuts to physician payments, which could disrupt collaborative care models.

### Supporting Long COVID Research

In August 2024, Sen Bernie Sanders (I-VT) introduced the Long COVID Research Moonshot Act of 2024, to which ACCP had provided input (<u>click here</u> to read ACCP's comments). This act would provide the NIH with funding to support studies, the pursuit of treatments, and the expansion of care for US patients affected by the condition. ACCP was joined by 47 national and local organizations in endorsing this important initiative. In ACCP's response, the 2022 paper published in the *Journal of the*  American College of Clinical Pharmacy (JACCP) titled "<u>A</u> <u>Primer on Post-COVID-19 Conditions and Implications</u> for Clinical Pharmacists" was cited, which explores how clinical pharmacists are essential team members in optimizing the treatment of patients with "post-COVID conditions."

### STAFF AND COMMITTEES LEADING THE WAY

### **Behind-the-Scenes Efforts**

ACCP staff and leaders continue to participate in weekly meetings and quarterly in-person meetings with Joint Commission of Pharmacy Practitioners member organizations, including ASHP and APhA. Many members are unaware that ACCP staff are engaged in various initiatives directly affecting clinical pharmacy including:

- participating in monthly task force meetings with the ACT (Academia-Community Transformation) Pharmacy Collaborative,
- -working alongside staff in the American Medical Association and other leading physician organizations to develop templates and resources for collaborative team care, and
- -serving as the primary contact for ACCP member engagement in guideline development by various major medical organizations.

### Scope Creep

Last, but not least, ACCP is acutely aware of the efforts of organized medicine to limit "scope creep" by other health professionals. In these efforts, organized medicine has compared quantitatively the education, training, and "patient care" hours of physicians with those of other health professionals including pharmacists. Regrettably, these comparisons are not specific to clinical pharmacists (as defined in ACCP's Standards of Practice for Clinical Pharmacists) and do not focus on comparative education and training in pharmacology or pharmacotherapy and their applications to patient care and medication optimization. In response, ACCP charged the 2024 Educational Affairs Committee, led by Sharon See, Sheila Allen, and Branden Nemecek, to compose an ACCP Commentary comparing formal education and training in the pharmacotherapeutics of physicians, physician assistants, nurse practitioners, and clinical pharmacists. The work of this committee will be published in JACCP in early 2025. This work is essential to ensuring our health care colleagues are well aware of our unique contributions to the medical team. All nomination materials, including letters, curricula vitae or resumes, and other supporting documents, can be submitted online to ACCP. For all awards, honors, and officer/board positions, the College strongly urges the nomination of qualified individuals who identify as members of underrepresented groups in ACCP. The online nominations portal specifies the nominating materials required for each award, honor, and elective office. This portal is available at www.accp.com/membership/nominations.aspx.

### **DEADLINES:**

**Due February 1, 2025** – Nominees' <u>supporting doc-</u> <u>uments</u> must be uploaded in the nominations portal for the fall 2025 awards (Robert M. Elenbaas Service, C. Edwin Webb Professional Advocacy, Russell R. Miller, Clinical Practice, Education, and Excellence in DEIA) and the 2026 elected offices.

**Due February 15, 2025** – <u>Nominations and support-</u> <u>ing documents</u> for the 2025 Parker Medal; nominations for the 2026 Therapeutic Frontiers Lecture Award, the 2025 "new" awards (New Investigator, New Clinical Practitioner, and New Educator), and the 2025 ACCP Fellows (FCCPs).

**Due April 1, 2025** – Nominees' <u>supporting documents</u> must be uploaded in the nominations portal for the 2025 "new" awards (New Investigator, New Clinical Practitioner, and New Educator) and the 2026 Therapeutic Frontiers Lecture Award.

### **DESCRIPTIONS:**

2025 ACCP Fellows: Fellowship is awarded in recognition of continued excellence in clinical pharmacy practice or research. Nominees must have been Full Members of ACCP for at least 5 years, must have been in practice for at least 10 years since receipt of their highest professional pharmacy degree, and must have made a sustained contribution to ACCP through activities such as presentation at College meetings; service to ACCP committees, PRNs, chapters, or publications; or election as an officer. Candidates must be nominated by any two Full Members other than the nominee, by any Fellow, or by any member of the Board of Regents. Current members of the Board of Regents, Foundation Board of Trustees, Pharmacotherapy Publications (PPI) Board of Directors, Credentials: Fellowship Committee, or ACCP staff are ineligible for consideration. Nomination deadline: February 15, 2025.

2025 Paul F. Parker Medal for Distinguished Service to the Profession of Pharmacy: Recognizes an individual who has made outstanding and sustained contributions to improving or expanding the profession of pharmacy in an area of professional service-including, but not limited to, patient care, leadership, administration, finance, technology, information processing, service delivery, models of care, and advocacy. The award is not limited to pharmacists or ACCP members. Nominations must consist of a letter detailing the nominee's qualifications for this award and his or her contributions to the profession of pharmacy; the nominee's curriculum vitae, resume, or biographical sketch as available; and a minimum of three letters of recommendation. At least one of these letters must be from an individual outside the nominee's current practice locale. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Parker Medal Selection Committee, or ACCP staff are ineligible. Nomination deadline: February 15, 2025, including supporting documents.

2026 Therapeutic Frontiers Lecture Award: Honors an internationally recognized scientist whose research is actively advancing the frontiers of pharmacotherapy. The recipient of this award is not required to be an ACCP member. Nominations must include a letter of nomination from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her sustained contributions to pharmacotherapy, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.

**2025 New Investigator Award:** This award highlights the research program of an ACCP member who has made a major impact on an aspect of clinical pharmaceutical science. Nominees must have been a Full Member of ACCP at the time of nomination and a member at any level for at least 3 years; they must have a research program with a significant publication record having a programmatic theme or an especially noteworthy single publication; and it must have been within 6 years since completion of their terminal professional pharmacy training or

degree, whichever is most recent. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's gualifications for this award and the significance/impact of his or her research program, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.

2025 New Clinical Practitioner Award: This award recognizes a new clinical practitioner who has made outstanding contributions to the health of patients and/or the practice of clinical pharmacy. Nominees must have been Full Members of ACCP at the time of nomination and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of

two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.

2025 New Educator Award: This award recognizes and honors a new educator for outstanding contributions to the discipline of teaching and to the education of health care practitioners. Nominees must have been Full Members of ACCP at the time of nomination and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. Diversity, equity, inclusion, and accessibility: Alignment with the mission and core values of the American College of Clinical Pharmacy



### FCCP Nominations Due February 15

Are you planning to nominate a colleague for Fellowship in the American College of Clinical Pharmacy (FCCP)? Fellowship in ACCP recognizes excellence in the practice and science of clinical pharmacy and is awarded to individuals who have made sustained contributions to the College and demonstrated exceptional performance in clinical pharmacy practice and/or research.

To be considered for Fellowship, candidates must be nominated by any of the following: 2 full members of ACCP, 1 Fellow of ACCP, or a member of the Board of Regents. Separate letters of recommendation are not required or considered in the evaluation process. Nominees for FCCP must (1) be Full Members of ACCP for at least 5 years, (2) have been in practice for at least 10 years since receipt of their highest professional pharmacy degree (Pharm.D. or BS), and (3) have made sustained contributions to ACCP.

Once the nomination period closes, eligible nominees receive email notification of their nomination and are asked to submit the necessary application materials to be considered for recognition as a Fellow. Completed applications are reviewed by the Credentials: Fellowship Committee and subsequently submitted to the ACCP Board of Regents for approval.

After nomination by their colleagues, Fellow candidates undergo a comprehensive evaluation of their service to the College and their practice and research accomplishments. Persons nominated as a Fellow must have made a substantial contribution to ACCP through activities such as presentations at College-sponsored meetings; service as a reviewer for ACCP, Pharmacotherapy/ JACCP, or the ACCP Foundation; contributions to College publications; service as a committee member; or contributions as a Practice and Research Network chair, chapter officer, or elected ACCP officer or regent. Practice and research criteria evaluated by the committee include examples of patient care service or educational programs developed by the nominee; certifications or other credentials earned; drug therapy management responsibilities; educational presentations; consultantships; service to publications; original research presentations, projects, funding, and publications; and other professional activities and awards.

Newly elected Fellows are inducted during the College's Annual Meeting and recognized at the Annual Fellows Dinner. Fellows may be recognized by the initials "FCCP" as part of their title as long as they are ACCP members in good standing. Nominations for FCCP are submitted online at <u>www.</u> <u>accp.com/membership/nominations.aspx</u>. The deadline for submission of nominations for 2025 Fellowship is February 15. The competition is only open to pharmacy students pursuing their first professional pharmacy degree from an accredited institution, or one that has been granted candidate status, who are in the first 2 years of their first professional pharmacy degree program (P1 and P2 students for 4-year programs; P1 and P2 students for 3-year accelerated programs; and the first 2 professional years of 0- to 6-year or 0- to 7-year programs). Only one team per institution may enter the competition. Institutions with branch campuses, distance satellites, or more than one interested team are encouraged to conduct a local competition. ACCP provides a written examination that institutions may use as a basis for their local competition, if they wish. Students are not required to be members of ACCP to participate. Team registration should be submitted online and must be initiated by a current faculty member at the respective institution. ### Washington Report ACCP-PAC Advocacy Update: Opportunities for Clinical Pharmacy in the 119th Congress

ACCP-PAC is the political voice of the clinical pharmacy profession. It is the only federal political action committee dedicated specifically



to advancing the practice of clinical pharmacists and the care of their patients. As the 119th Congress gets underway on Capitol Hill, ACCP-PAC has been active in its bipartisan support for members of Congress who have demonstrated leadership on issues important to ACCP members, such as Medicare funding for pharmacy residencies.

Through your support for ACCP-PAC, members of the College can attend fundraising events that provide a unique setting for educating representatives and senators about the essential work of clinical pharmacists in improving medication outcomes on behalf of patients.

ACCP-PAC recently attended an event hosted by Rep Earl L. "Buddy" Carter (R-GA), who is one of just 2 pharmacists currently serving in the US Congress.

### **About Representative Carter**

Representative Carter is a pharmacist currently serving as the representative for Georgia's First Congressional District. The district is based in Savannah and includes most of the state's coastal southern area. Representative Carter was first elected to Congress in 2015 after serving the people of Georgia as a state representative (2005-2009) and state senator (2009-2014).

Representative Carter is a well-established leader on health care issues in Congress and will serve as chair of the House Energy and Commerce Committee Subcommittee on Health for the 119th Congress. In this powerful role, Representative Carter's committee will hold jurisdiction over key provisions in the Medicare program.

In a statement, Representative Carter highlighted his health care background:

As a pharmacist for more than 40 years, I am thrilled to sit atop the Health Subcommittee for the 119th Congress.... The goal of this subcommittee is as straightforward as it is consequential: help Americans live healthier and longer lives. We will work toward this goal, in lockstep with President Trump, to tackle our nation's chronic disease epidemic, increase price transparency, incentivize competition, combat harmful health care consolidation, fight the scourge of fentanyl, and build a health care system that puts patients before profits. Through transparency, competition, and innovation, we will Make America Healthy Again.

### ACCP's Priorities for the 119th Congress

ACCP's top advocacy priority on Capitol Hill is to establish Medicare coverage and payment for comprehensive clinical pharmacy services that optimize medication use for patients. Beyond this vital initiative, ACCP will work with its pharmacy colleagues and other key health care stakeholders—including physician organizations to advance the following legislative efforts in the 119th Congress:

### Protecting PGY1 Residency Funding

Substance Use Prevention and Pharmacy Oriented Recovery Treatment Prescription Act (SUPPORT Rx Act)

Advancing Medicare Coverage for Pharmacogenetic Consultations

### ACCP Oncology Genomics Certificate Program Begins March 4

This unique certificate program blends interactive live online learning (by Zoom) with self-study programming to equip clinical pharmacists with the necessary skills to apply oncology genomics to practice. From March 4 through May 19, participants will acquire skills to interpret genomic reports, develop treatment plans on the basis of genomic data, interact with an interprofessional molecular oncology team, and learn strategies for implementing a Molecular Tumor Board at their own institutions.

Expert faculty will lead weekly online sessions that provide foundational knowledge about somatic genomics, next-generation sequencing (NGS), and necessary tools for interpreting NGS reports to develop effective treatment plans. Faculty will delve into pertinent oncology specialty topics, including lung cancer genomics, gynecologic cancer genomics, and hematologic malignancies. Strategies for implementing a Molecular Tumor Board will be demonstrated together with exploration of related ethical, legal, and social issues for consideration. Participants will have the opportunity to participate in facilitated discussions, receive mentorship to solidify learning, and gain practice through practice sessions and case-based presentations with peers. Selfstudy modules and exercises will reinforce program topics.

Registered participants who complete this program will receive a certificate of completion and 2.0 CEUs (20.0 contact hours).
