## University of Kentucky College of Pharmacy Crowned 2024 ACCP Clinical Pharmacy Challenge Champion



The three-member team from the University of Kentucky College of Pharmacy captured the title of 2024 ACCP Clinical Pharmacy Challenge Champion in an exciting match with the team from the University of Health Sciences and Pharmacy in St. Louis, St. Louis College of Pharmacy. From an initial field of 110 teams, these two institutions advanced through four online rounds of competition as well as live quarterfinal and semifinal matches to face each other in the Final Round held on Monday, October 14, at the ACCP Annual Meeting in Phoenix.

The Clinical Pharmacy Challenge, now in its second decade of excellence, affords teams of three pharmacy students the opportunity to compete in a “quiz bowl”-type competition. Each round of competition has three segments: Trivia-Lightning, Clinical Case, and Jeopardy-style items. Items are written and reviewed by an expert panel of ACCP members.

A large and enthusiastic crowd of ACCP Annual Meeting attendees gathered to cheer on both teams in the final round of the 2024 match. Representing

Team Kentucky were Cameron Howell (team leader), Catherine Barfield, and Kaylee Meador. Team St. Louis was represented by Connor Lynch (team leader), Lindsey Holhubner, and Isabella Roberts. The teams battled back and forth during the round. Team Kentucky had a significant lead after the Trivia-Lightning segment; however, during the Clinical Case section, Team St. Louis closed the gap with a strong performance. The final section of the match was the Jeopardy-style round, where teams were presented with 15 items (three items of 100, 200, or 300 points) in each of the following categories: Cardiovascular Disorders, Critical Care/Emergency Medicine, Immunology/Transplantation, Pain and Palliative Care, and Potpourri. The teams employed strategic choices as they navigated the Jeopardy grid, selecting the item categories they felt would match their own unique strengths. Team Kentucky took a commanding lead in the Jeopardy-style round and prevailed to claim the title of 2024 ACCP Clinical Pharmacy Challenge Champion.

Winners of the Best Student, Best Resident or Fellow Poster, and Best Poster awards from the 2024 ACCP Annual Meeting in Phoenix were announced Monday, October 14, 2024, after they had delivered platform presentations of their research. Posters presented at the Annual Meeting described original research, innovative clinical pharmacy services and programs, case reports, systematic reviews/meta-analyses, and student, resident, and fellow research-in-progress.

Marisa Marcath from Wayne State University, Eugene Applebaum College of Pharmacy and Health Sciences, Detroit, Michigan, won the Best Student Poster Award. She presented “Impact of #PlanA Reproductive Health Seminars on College Students’ Contraception and Safe Sex Knowledge.” Her coauthors included Kayla Craig, Pharm.D. Candidate and Mary Beth O’Connell, Pharm.D. (Wayne State University, Eugene Applebaum College of Pharmacy and Health Sciences, Detroit, Michigan).

The other student finalist in this category was Landon Welch from the University of Utah College of Pharmacy, Salt Lake City, Utah. Landon presented the abstract titled “Association of Atrial Fibrillation with Lamotrigine in Bipolar I Disorder: An Observational Cohort Study.” The research was conducted in collaboration with Sodam Kim, Pharm.D. (Department of Pharmacy Systems and Outcomes and Policy, University of Illinois Chicago, Chicago, Illinois); Bertha De Los Santos, Pharm.D., M.S. The winner of the Best Resident or Fellow Poster Award was Kennedy Concannon, Pharm.D., from the Mayo Clinic Hospital in Rochester, Minnesota. Concannon presented “Concurrent Apixaban with Itraconazole or Posaconazole Pharmacokinetic and Clinical Outcome Evaluation in Cardiothoracic Transplant Recipients.” The research was conducted in collaboration with Rachel Huntsman, Pharm.D. and Adley Lemke, Pharm.D. (Department of Pharmacy, Mayo Clinic

Dillen presented the abstract titled “Impact of an Addiction Medicine Consult Service on Medications for Opioid Use Disorder Initiation in Hospitalized Patients.” The research was conducted in collaboration with Megan Baumgartner, Pharm.D., BCPS and Alexandria Taylor, Pharm.D., BCPS (UPMC St. Margaret); Frank D’Amico, Ph.D. (Department of Biostatistics, UPMC St. Margaret); Sanketh Proddutur, M.D. (UPMC St. Margaret); and Joshua Shulman, M.D. (UPMC Shadyside, Pittsburgh, Pennsylvania).

Lusi Zhang, Pharm.D., MPI, from the University of Minnesota College of Pharmacy in Minneapolis, Minnesota, won the Best Poster Award for her poster.

Zhang's abstract was titled "Polygenic Interactions with Anticholinergic Burden Impact Cognition and Brain Structure in Psychotic Disorders." Pearce presented the abstract titled "CYP2C19 Genotype-Guided Antiplatelet Therapy After Percutaneous Coronary Intervention in Patients with High Bleeding Risk: Evaluating the Clinical Impact in a Real-world Setting." The research was conducted in collaboration with Kayla Tunehag, Pharm.D., MSPH, and Craig R. Lee, Pharm.D., Ph.D., FCCP (Division of Pharmacotherapy and Experimental Therapeutics, Eshelman School of Pharmacy, University of North Carolina at Chapel Hill), as well as George A. Stouffer, M.D. and Joseph S. Rossi, M.D., MSCI (Division of Cardiology and McAllister Heart Institute, School of Medicine, University of North Carolina at Chapel Hill). Szempruch presented the abstract titled "Granulocyte Colony-Stimulating Factor Use in Alemtuzumab vs. Anti-thymocyte Globulin Induction with Rapid Steroid Withdrawal Regimen in Adult Kidney Transplant

Recipients." The research was conducted in collaboration with Jason Ifeanyi, Pharm.D. and Laura Chargualaf, Pharm.D., BCPS (University of North Carolina Medical Center), as well as Mary Chandran, Pharm.D., FCCP, FAST, BCTXP, BCPS, CPP (University of North Carolina Medical Center, Chapel Hill).

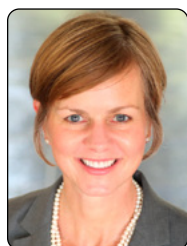

All nomination materials, including letters, curricula vitae or resumes, and other supporting documents, can be submitted online to ACCP. For all awards, honors, and officer/board positions, the College strongly urges the nomination of qualified individuals who identify as members of underrepresented groups in ACCP. The online nominations portal specifies the nominating materials required for each award, honor, and elective office. This portal is available at [www.accp.com/membership/nominations.aspx](http://www.accp.com/membership/nominations.aspx).

### **DEADLINES:**

**Due November 30, 2024** – Nominations for the fall 2025 awards (Robert M. Elenbaas Service, C. Edwin Webb Professional Advocacy, Russell R. Miller, Clinical Practice, Education, and Excellence in DEIA) and the 2026 elected offices.

**Due February 1, 2025** – Nominees' supporting documents must be uploaded in the nominations portal for the fall 2025 awards (Robert M. Elenbaas Service, C. Edwin Webb Professional Advocacy, Russell R. Miller, Clinical Practice, Education, and Excellence in DEIA) and the 2026 elected offices.

**Due February 15, 2025** – Nominations and supporting documents for the 2025 Parker Medal; nominations for the 2026 Therapeutic Frontiers Lecture Award, the 2025 “new” awards (New Investigator, New Clinical Practitioner, and New Educator), and the 2025 ACCP Fellows (FCCPs).

**Due April 1, 2025** – Nominees' supporting documents must be uploaded in the nominations portal for the 2025 “new” awards (New Investigator, New Clinical Practitioner, and New Educator) and the 2026 Therapeutic Frontiers Lecture Award.

### **DESCRIPTIONS:**

**2026 Officers and Regents:** President-Elect, Secretary, Regents, and ACCP Foundation Trustees. Nominees must be Full Members of ACCP and should have (1) achieved excellence in clinical pharmacy practice, research, or education; (2) demonstrated leadership capabilities; and (3) made prior contributions to ACCP. Current members of the Nominations Committee are ineligible. Please note that any qualifying Full Member may nominate themselves for office. **Nomination deadline: November 30, 2024.**

**2025 ACCP Fellows:** Fellowship is awarded in recognition of continued excellence in clinical pharmacy practice or research. Nominees must have been Full Members of ACCP for at least 5 years, must have been in practice for at least 10 years since receipt of their highest

professional pharmacy degree, and must have made a sustained contribution to ACCP through activities such as presentation at College meetings; service to ACCP committees, PRNs, chapters, or publications; or election as an officer. Candidates must be nominated by any two Full Members other than the nominee, by any Fellow, or by any member of the Board of Regents. Current members of the Board of Regents, Foundation Board of Trustees, Pharmacotherapy Publications (PPI) Board of Directors, Credentials: Fellowship Committee, or ACCP staff are ineligible for consideration. **Nomination deadline: February 15, 2025.**

**2025 Paul F. Parker Medal for Distinguished Service to the Profession of Pharmacy:** Recognizes an individual who has made outstanding and sustained contributions to improving or expanding the profession of pharmacy in an area of professional service – including, but not limited to, patient care, leadership, administration, finance, technology, information processing, service delivery, models of care, and advocacy. The award is not limited to pharmacists or ACCP members. Nominations must consist of a letter detailing the nominee's qualifications for this award and his or her contributions to the profession of pharmacy; the nominee's curriculum vitae, resume, or biographical sketch as available; and a minimum of three letters of recommendation. At least one of these letters must be from an individual outside the nominee's current practice locale. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Parker Medal Selection Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2025, including supporting documents.**

**Robert M. Elenbaas Service Award:** Considered a lifetime achievement award, this honor is conferred only when a particularly noteworthy candidate is identified in recognition of outstanding contributions to the vitality of ACCP or to the advancement of its goals that are well above and beyond the usual devotion of resources, be it time, energy, material goods, or a combination thereof. It is expected that nominees for this award will have been serving the mission of ACCP/clinical pharmacy for at least 20 years at the time of nomination. Nominations will consist of a letter from an ACCP member detailing the nominee's qualifications for the award and his or her contributions to the College, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, or ACCP staff

are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**C. Edwin Webb Professional Advocacy Award:** Like the Elenbaas Award above, this is a lifetime achievement award. The Webb Award is given only when a particularly noteworthy candidate is identified who has made outstanding contributions to the visibility and value of clinical pharmacy in national policy, intraprofessional, and interprofessional arenas; has assembled a record of mentoring others who have gone on to assume a health professions and health policy leadership role; and is recognized as an ambassador for clinical pharmacy both within and outside the profession. It is expected that nominees for this award will have advocated for the mission of ACCP/clinical pharmacy for at least 20 years at the time of nomination. Nominations will consist of a letter from an ACCP member detailing the nominee's qualifications for this award and his or her contributions to the College, the nominee's curriculum vitae, and a minimum of two letters of recommendation from either ACCP or non-ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice/place of employment. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, or ACCP staff are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**2026 Therapeutic Frontiers Lecture Award:** Honors an internationally recognized scientist whose research is actively advancing the frontiers of pharmacotherapy. The recipient of this award is not required to be an ACCP member. Nominations must include a letter of nomination from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her sustained contributions to pharmacotherapy, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.**

**2025 Russell R. Miller Award:** Recognizes an ACCP member who has made outstanding contributions to the professional literature of clinical pharmacy, either as a single, landmark contribution or by sustained excellence over time. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and

his or her contributions to the professional literature, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**2025 Clinical Practice Award:** Recognizes an ACCP member who has developed an innovative clinical pharmacy service, provided innovative documentation of the impact of clinical pharmacy services, provided leadership in developing cost-effective clinical pharmacy services, or shown sustained excellence in providing clinical pharmacy services. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her contributions to clinical pharmacy practice, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**2025 Education Award:** Recognizes an ACCP member who has demonstrated excellence in the classroom or clinical training site, conducted innovative research in clinical pharmacy education, demonstrated exceptional dedication to continuing education programs, or demonstrated leadership in the development of education programs. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and his or her contributions to health professional education, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**2025 Excellence in Advancement of Diversity, Health Equity, Inclusion, and Accessibility Award:** Recognizes an ACCP member who has shown exceptional

dedication and impact in their efforts to promote or advance diversity, health equity, inclusion, and accessibility initiatives or programs via advocacy, education, clinical practice, research, or leadership within the pharmacy profession, health care institutions, or local communities. Nominations consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and their contributions to the field, the nominee's curriculum vitae, and two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. The chair of the Awards Committee sends a letter of acknowledgment to each member submitting a nomination. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: November 30, 2024. Supporting documents are due February 1, 2025, as noted above.**

**2025 New Investigator Award:** This award highlights the research program of an ACCP member who has made a major impact on an aspect of clinical pharmaceutical science. Nominees must have been a Full Member of ACCP at the time of nomination and a member at any level for at least 3 years; they must have a research program with a significant publication record having a programmatic theme or an especially noteworthy single publication; and it must have been within 6 years since completion of their terminal professional pharmacy training or degree, whichever is most recent. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her research program, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.**

**2025 New Clinical Practitioner Award:** This award recognizes a new clinical practitioner who has made outstanding contributions to the health of patients and/or the practice of clinical pharmacy. Nominees must have been Full Members of ACCP at the time of nomination

and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. Current members of the Board of Regents, Foundation Board of Trustees, PPI Board of Directors, Awards Committee, or ACCP staff are ineligible. **Nomination deadline: February 15, 2025. Supporting documents are due April 1, 2025, as noted above.**

**2025 New Educator Award:** This award recognizes and honors a new educator for outstanding contributions to the discipline of teaching and to the education of health care practitioners. Nominees must have been Full Members of ACCP at the time of nomination and members at any level for at least 3 years. In addition, nominees must have completed their terminal professional pharmacy training or degree (whichever is most recent) within 6 years from the time of selection by the Board of Regents. If an individual pursues an additional degree beyond his or her professional pharmacy degree or training (i.e., Ph.D.), this additional degree will not be considered a terminal degree, and the 6-year time interval will extend from completion of the terminal pharmacy training or degree. Fellows of ACCP (i.e., "FCCPs") are ineligible. Nominations will consist of a letter from an ACCP member to the chair of the Awards Committee detailing the nominee's qualifications for this award and the significance/impact of his or her clinical contributions, the nominee's curriculum vitae, and a minimum of two letters of recommendation from other ACCP members. At least one of these letters must be from an individual outside the nominee's current institute of practice. Self-nominations are not permitted. In conjunction with the 2024 ACCP Annual Meeting in Phoenix, ACCP-PAC organized the annual Political Action Committee (PAC) PRN Challenge to determine which PRNs could generate the greatest PAC support.

Throughout the Challenge, PRN members who made a PAC contribution online could designate a PRN to receive credit for their contribution. The 2024 Challenge recognized two winners:

- The Community-Based PRN won the contest for the total dollars raised!
- The Perioperative Care PRN won the contest for the greatest percentage of PRN members who contributed!

The winning PRNs will receive coveted preferential time slots for their business meetings at the 2025 ACCP Annual Meeting. Thank you to everyone who has participated in ACCP’s advocacy activities so far in 2024.

#### Why Does ACCP Have a PAC?

In 2010, the ACCP Board of Regents made the decision to establish ACCP-PAC to allow the College to be active in supporting the campaigns of members of Congress who share the College’s core values and policy vision, just as ACCP is active in asking for the support of these elected officials in helping to advance its shared policy goals. Running for federal office is expensive, and members of Congress rely on contributions from PACs to fund their campaigns.

#### Who Receives PAC Support?

ACCP-PAC is nonpartisan and supports candidates regardless of political party affiliation. ACCP-PAC supports candidates on the basis of certain established criteria:

- Position on key health care committees in Congress
- Proven support for pharmacy and health care–related issues
- Previous health care experience

The key health care–related committees in the House of Representatives are the Ways and Means Committee and the Energy and Commerce Committee; in the Senate, these are the Finance Committee and the Health, Education, Labor and Pensions Committee.

#### How Does ACCP-PAC Decide Which Candidates to Support?

ACCP-PAC is a member-driven organization, and its strategic policy decisions – including those related to which candidates receive financial contributions from ACCP-PAC – are made by the [PAC Governing Council](#).

ACCP members who contribute to the PAC may recommend candidates to receive contributions. All PAC contributor recommendations will be considered; however, not all requests may be accommodated.

ACCP-PAC is also supported by the College’s network of PAC captains who represent ACCP’s PRNs on advocacy and political action. The College is excited about this renewed effort to develop a core of focused leaders to drive participation in its advocacy efforts.

### Nancy Shapiro Succeeds Suzanne Nesbit as ACCP Appointee to Commission on Credentialing

ACCP’s appointee to the American Society of Health-System Pharmacists (ASHP) Commission on Credentialing (COC) will transition from Suzanne A. Nesbit, Pharm.D., FCCP, BCPS, CPE, to Nancy L. Shapiro, Pharm.D., FCCP, BCACP, CACP, in January 2025. The COC is focused

on improving and ensuring the quality of more than 2500 pharmacy residency training programs. Its work includes developing training program standards, performing on-site and electronic surveys to assess performance against the standards, and recommending a length of accreditation for each program evaluated to the ASHP Board of Directors. In addition to ACCP, the other partner organizations represented on the COC are the Academy of Managed Care Pharmacy, the American Association of Colleges of Pharmacy, and the American Pharmacists Association (APhA).

Nesbit is a clinical pharmacy specialist in pain management in the Department of Pharmacy and research associate in the Department of Oncology and Center for Drug Safety and Effectiveness at the Bloomberg School of Public Health at the Johns Hopkins Hospital. She is also the residency program director (RPD) for their PGY2 residency in pain management and palliative care and a past president of ACCP. Nesbit served as the College's seventh appointee to the COC. In her final COC report to the Board of Regents, Nesbit reflected on her experience:

It has been a privilege to serve as ACCP's representative to the ASHP COC over the past 3 years. My experience as an RPD and guest surveyor has been invaluable in understanding the Commission's framework. I was also fortunate to be part of the workgroup revising the Competency Areas, Goals, and Objectives (CAGOs) for both PGY1 and PGY2 programs. This was a crucial time for ACCP to contribute its perspective and input on the future of residency training.

Nesbit participated in her last in-person COC meeting as the ACCP representative in August, with Shapiro attending in observer status. Observers are invited to participate in all aspects of the meeting, but do not yet vote on program accreditation/reaccreditation status or any other decisions related to new programs or initiatives. Shapiro is a clinical professor and associate head for Education, Department of Pharmacy Practice,

University of Illinois at Chicago College of Pharmacy. She serves as coordinator and clinical pharmacist of the pharmacist-managed antithrombosis clinic at the University of Illinois Hospital and Health Sciences System. Until 2022, Shapiro served as the director of the PGY2 ambulatory care pharmacy residency. When asked about representing ACCP on the COC, she stated:

I'm honored to serve as ACCP's representative on the COC. I have been a long-standing residency preceptor, PGY2 Ambulatory Care RPD, and volunteer peer surveyor for many residency accreditation visits. I will bring this experience and insight as a member of the COC to achieve and maintain quality pharmacy residency training, while working to streamline documentation requirements. I look forward to serving in this role.

The College would also like to recognize other ACCP members currently serving on the 30-member COC as appointees of ASHP, including Sandra Cuellar, Pharm.D., BCOP; Sarah Ray, Pharm.D., FAPhA, BCPS; Winter J. Smith, Pharm.D., BCPS; and Todd A. Walroth, Pharm.D., BCCCP, BCPS. ACCP member Jean-Venable ("Kelly") Goode, Pharm.D., FCCP, FAPhA, BCPS, is currently serving as the APhA appointee. The APLD program is designed to provide members with an opportunity to learn leadership principles within the framework of ACCP governance through the perspectives of both elected leaders and staff. APLD prepares participants for service as leaders within ACCP as well as the pharmacy profession. The program begins with an in-person session during the Annual Meeting, followed by 16 interactive virtual sessions on leadership topics throughout the year. These sessions provide details on the history of ACCP and its mission, core values, and governance and build on established leadership principles, including those from leadership texts used by the Board of Regents. APLD members work in groups to complete capstone projects that move critical strategic initiatives forward and are also paired with mentors who have served on one of the ACCP boards. All mentors and speakers for the program volunteer their efforts as part of their commitment to serve ACCP.

The Mentored Research Investigator Training (MeRIT) program is the Foundation’s latest support mechanism for investigator development, with a rapidly expanding record of participant success. This 2-year longitudinal

MeRIT is designed to help pharmacists develop the abilities necessary to conduct investigator-initiated research, either independently as a principal investigator or collaboratively as an active coinvestigator within a research team. Ideal candidates are pharmacy practitioners or faculty with limited research experience who are:

- Committed to incorporating research into their professional careers
- Interested in generating research themes or obtaining preliminary data for larger funding opportunities
- Aspiring to be active principal investigators or coinvestigators within a research team
- Able to commit at least 10% effort to research

The Focused Investigator Training (FIT) program is a 5-day, intensive, hands-on program to help investigators succeed in a competitive research funding environment. Each experienced investigator-participant takes the necessary steps toward maximizing the competitiveness of a K, R01, or similar investigator-initiated application for submission to the NIH or other major funding source. Participants are challenged to carefully examine research aims and explore individual professional research goals. By the end of the program, participants will have taken critical steps toward fine-tuning their applications to meet study section reviewers' expectations. The program's experienced and funded faculty mentors deliver a curriculum that offers:

- Small-group proposal development sessions
- Tip-rich discussions
- One-on-one mentor/statistician appointments
