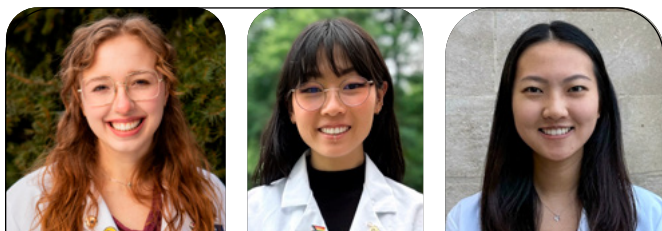


University of Michigan College of Pharmacy Team Crowned 2024 ACCP Clinical Research Challenge Champion

Competition in the 2024 ACCP Clinical Research Challenge (CRC) began February 12 with 82 teams vying for a spot in Round 2: Letter of Intent (LOI) Submission. Teams achieving the top 40 scores after the initial online Journal Club round submitted an LOI. Teams achieving the top 20 scores after round 2 were invited to compete in Round 3: Research Protocol Development. Teams were tasked with developing a research proposal

designed to demonstrate the value of clinical pharmacy-led services and/or initiatives to improve health outcomes among solid organ transplant recipients. Teams were provided a specific research environment in which to formulate their proposals.

The proposals were reviewed by the CRC Review Panel, and submissions ranking in the top one-third were referred to the CRC Oversight Panel for evaluation and selection of awards. Please join ACCP in congratulating the finalists and the award-winning team.


Reserve Your Room at the Sheraton Phoenix Downtown

DEIA Task Force to Become a Standing Committee

After approval by a special vote of the ACCP membership, the ACCP Bylaws will be amended to include a new Diversity, Equity, Inclusion, and Accessibility (DEIA) standing committee. This revision was proposed by the 2024 Task Force on DEIA to ensure that essential, ongoing DEIA activities are fulfilled. The committee will continue to provide input and feedback to the ACCP Board of Regents (BOR) on implementation of the DEIA plan and all issues relevant to DEIA, as well as review and score applicants for DEIA travel awards; vet, index, and maintain resources for the DEIA toolkit; recommend relevant DEIA communications to ACCP; and propose DEIA programming for ACCP members, among others.

The standing committee will replace the DEIA Task Force going forward. This change to the bylaws was approved by the 2024 Organizational Affairs Committee, endorsed by the BOR, and approved by 78% of member votes cast during the special vote.

Announcing New DEIA Travel Awards for Residents, Fellows, Graduate Students, and New Practitioners

As part of ACCP's commitment to decreasing barriers to clinical pharmacy career paths and creating an inclusive culture for all, the College will offer up to five Annual Meeting travel awards for residents, fellows, graduate students, and new practitioners from underrepresented groups.

Travel awards cover the cost of registration to attend the ACCP Annual Meeting and provide a \$1000 stipend toward the cost of transportation and lodging for the meeting.

Current members of ACCP who identify as an individual from an underrepresented dimension of identity and are enrolled in a residency or fellowship or a full-time graduate studies program or are within their first 6 years of practice after completion of training are eligible

for the award. Underrepresented dimensions of identity include, but are not limited to, persons from racial, ethnic, gender, and sexual minority groups; persons with disabilities; and persons otherwise adversely affected by persistent poverty, discrimination, or inequality.

ACCP Member Spotlight: Christine Cadiz



Christine Cadiz, Pharm.D., is an associate professor of clinical pharmacy practice and one of the founding faculty members in the Department of Clinical Pharmacy Practice at the University of California Irvine School of Pharmacy & Pharmaceutical Sciences. She completed undergraduate education at University of California Santa Barbara, earned a Pharm.D. degree from University of California San Diego School of Pharmacy & Pharmaceutical Sciences, and completed a PGY1 residency at University of California San Francisco Medical Center.

In her current role, Cadiz practices as a pharmacist on a multidisciplinary advanced heart failure and mechanical circulatory support team at University of California Irvine Health. She is currently launching a pilot post-discharge clinic for intensive guideline-directed medical therapy optimization that incorporates remote physiologic monitoring. In her role as faculty, Cadiz teaches cardiology pharmacotherapy and has recently developed an advanced cardiology elective course. She precepts introductory and advanced pharmacy practice experience students as well as residents in the advanced heart failure and left ventricular assist device clinic setting. She has a passion for teaching and precepting as well as introducing young persons to science, technology, engineering, and math (STEM) subjects.

ACCP COMMENTARY

Decoding pharmacogenomic test interpretation and application to patient care



Cadiz's path to pharmacy was somewhat nontraditional. Although her father was a pharmacist in Vietnam, he did not practice pharmacy when he came to the United States in 1975 but rekindled his pharmacy career in the late 1990s. While in high school, Cadiz recalls the late nights her father spent independently studying after work, often through the night, for 1 year straight. This allowed her father to pass the pharmacy licensure examinations and achieve his dream of opening an independent pharmacy. Although Cadiz was inspired by her father's grit and determination, she did not initially view pharmacy as her dream career path. After completing degrees in aquatic biology and cultural anthropology, she worked in marine biology research and then earned an M.A. degree in teaching, after which she taught middle school science for several years. Although she loved teaching, she desired to pursue additional education. At this time in Cadiz's life, she was more mature and open-minded and had a greater awe and understanding of what her father had achieved. After researching the possibilities a career in pharmacy offered, she realized it was a great fit. During her pharmacy education and in subsequent years, she spearheaded programs to introduce K-12 students to careers in STEM and pharmacy. Cadiz always knew she wanted to practice in an area of pharmacy that afforded teaching opportunities and ample direct patient contact. As a clinical pharmacist in academia, with a specialty in transitions of care and cardiology, Cadiz fulfills her two passions, teaching students and serving patients.

Cadiz believes her ACCP membership has added a great deal of value to her career and practice. Through a network of pharmacist colleagues with expertise in her practice area, the PRNs have created a network for sharing clinical pearls on the basis of experience and provide guidance when starting new programs or creating pathways and protocols. She believes there is much to gain from learning about the challenges other practitioners have faced as well as their successes. In the past few years, Cadiz has become more involved with PRN committees, particularly the Education and Training Committee, to provide opportunities to students and trainees and collaborate on educational programming. Cadiz feels it was particularly rewarding to work with a group of passionate individuals within the ACCP Clinical Practice Affairs Task Force to describe best practices for incorporating interprofessional practice in the community setting.

Cadiz has developed a passion for recognizing, evaluating, and addressing social determinants of health when caring for patients. When she was in school, her focus was on learning how to treat diseases with both pharmacotherapy and nonpharmacologic lifestyle changes, and she didn't fully recognize the importance of evaluating barriers beyond medication cost and adherence or the profound impact of unnoticed barriers on patient outcomes. Cadiz was influenced by the importance of social determinants of health while caring for a patient with resistant hypertension. The degree of polypharmacy was significant; the patient was taking more than

15 medications. The team struggled to identify why she was not meeting her blood pressure goal despite excessive pharmacotherapy, access to medications, frequent follow-ups, and good adherence. All medications were packaged in labeled monthly blister packs. Given the number of medications, the patient had two blister packs for morning medications, one for afternoon medications, and two for nighttime medications, which were labeled “Morning, Afternoon, or Bedtime” in large print in the patient’s native language. One day in the clinic, when the patient had concerns of frequent light-headedness, Cadiz looked closely at the blister packs and noticed that the medications taken did not correspond to the current day of the month and were not being taken in order. Because she had established good rapport with the patient, Cadiz was able to identify, through gentle questioning, that the patient could not read and did not know which pack to take. The patient had been using a random pack three times a day; consequently, some medications were taken at double or triple the prescribed dose and others were being missed altogether. This barrier was one that was easily missed, given that it was not as readily apparent as others that were more recognizable. It was rewarding for Cadiz to see that with empathy, additional support, and creative labeling, the patient was able to independently manage her medications, minimize adverse effects, and achieve her blood pressure goal. Cadiz believes it crucial that the health care team assess for barriers that are not readily apparent and teach learners the importance of doing so in order to advance health equity.

Cadiz is very involved in advocacy and believes it important to be familiar with constantly changing legislation that affects health care and pharmacy practice. For the past 2 years, Cadiz has served as a member of the Government Affairs Advisory Committee in the California Society of Health-System Pharmacists to review proposed legislation related to the practice of pharmacy, make recommendations on position and level of advocacy, and propose amendments to protect and advance the profession. Cadiz would advise pharmacists, students, and residents to start by getting involved with local and state organizations and attending legislative days. This is a great way to learn about and participate in advocacy efforts.

In her spare time, Cadiz loves to go camping with her husband and two boys, surf, hike, eat, travel, and snuggle up on the couch. Even though Cadiz is clearly very accomplished, she has personal goals she would still like to achieve. She is a very active person who loves adventure and travel and would still like to get barreled on a wave while surfing and summit Kilimanjaro. She has

gotten close to achieving these goals by wiping out in a tiny barrel and traveling to Tanzania and seeing Mount Kilimanjaro, but she doesn’t count these as accomplishments checked ... yet!

Washington Report

Clinical Pharmacists on Capitol Hill: ACCP Members Take Action to Support PGY1 Residency Funding

ACCP recently joined with colleagues from across the pharmacy profession, and other health professions, to support an effort led by Sen. Amy Klobuchar (D-MN) to protect CMS funding for postgraduate year one (PGY1) pharmacy residency programs.

Over 1300 ACCP members and supporters mobilized in support of Senate action to protect pass-through funding for PGY1 residency programs. Thank you for this show of support.

Background

Since 2019, CMS has implemented changes to its auditing procedures for clinical pharmacy residency programs, but without updating its regulations or providing guidance on how residency programs can stay in compliance with these auditing procedures.

Medicare pass-through funding for PGY1 residency programs is critical to ensuring the sustainability of the clinical pharmacy profession. However, under these burdensome Medicare auditing procedures, many PGY1 residency programs have been stripped of funding.

Building Support on Capitol Hill

ACCP is working to support an advocacy effort led by its colleagues at the American Society of Health-System Pharmacists to support an intervention by Congress to protect PGY1 residency funding and prohibit these unnecessary funding clawbacks that jeopardize PGY1 residency programs.

Most recently, in the Senate, Senator Klobuchar (D-MN) led an effort that called for the Labor/Health and Human Services Appropriations Subcommittee to include language directing CMS to provide clear guidance before clawing back residency funding.

Over 1300 ACCP members and supporters came together to send more than 2600 letters urging members of the Senate to support Senator Klobuchar’s

initiative. ACCP's PRN PAC captains were instrumental in disseminating ACCP's request through their PRN networks. The College thanks everyone who mobilized on this issue.

Current Status in the Senate

This appropriations request was part of an ongoing legislative effort to seek an immediate resolution to the PGY1 funding issue. The following U.S. senators responded to ACCP's request [and signed Senator Klobuchar's letter](#) to Appropriations Committee leaders:

The College thanks these senators for their bipartisan support. ACCP has worked closely with Senator Welch's office over many years. [ACCP-PAC recently supported his](#) reelection effort.

Next Steps

As the Senate appropriations process unfolds, ACCP will continue to work with these offices to protect pass-through funds to hospitals for the operation of pharmacy residency programs.

ACCP will also explore opportunities to engage with other allied health professionals who are also affected by Medicare's auditing process, including nurses; clinical pastoral counselors and chaplains; occupational, speech, and physical therapists; medical laboratory scientists; and other integral members of patient care teams and the health care system.

The Washington office will also pursue strategic opportunities to engage with leaders on the Senate Finance Committee, which holds primary jurisdiction over the Medicare program. Please keep the College informed of any local advocacy related to this issue, or other information related to PGY1 residency audits, that might be helpful in support of this effort.

Member-Driven Advocacy: ACCP Represented in FDA Compounding Listening Session for Pharmacy Groups

The session opened with presentations from FDA staff outlining FDA guidance around compounding, specifically sections 503A and 503B of the Federal Food, Drug, and Cosmetic Act. After the presentations, the session was opened up for questions and comments from the attendees. Most comments centered on a desire for more clarity on FDA guidance and requests for additional flexibility regarding drug shortages and approved bulk ingredients. Because this was a listening session, FDA staff acknowledged comments but declined to provide any specific response outside the previously prepared materials. Pharmacotherapy Publishes Consensus Recommendations for the Use of Novel Antiretrovirals in Persons with HIV Who Are Heavily Treatment-Experienced and/or Who Have Multidrug-Resistant HIV-1

FDA approval of ibalizumab, fostemsavir, and lenacapavir offers encouraging options for virologic suppression and immune restoration for patients with HIV who are heavily treatment-experienced and/or who have multidrug-resistant HIV-1. However, integrating these novel antiretroviral agents into practice is complex.

The consensus recommendations for the use of novel antiretrovirals in persons with HIV who are heavily treatment-experienced and/or who have multidrug-resistant HIV-1 were developed by a multidisciplinary panel of experts in infectious diseases led by ACCP members David B. Cluck and Daniel B. Chastain. The recommendations have been reviewed and endorsed by the American College of Clinical Pharmacy and the American Academy of HIV Medicine and published in the May 2024 issue of *Pharmacotherapy*.

The consensus recommendations provide an algorithmic approach to major decisions for selecting and monitoring these novel antiretroviral agents. 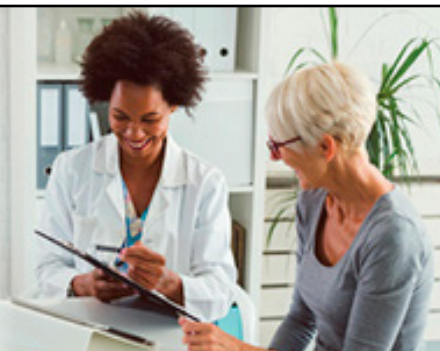

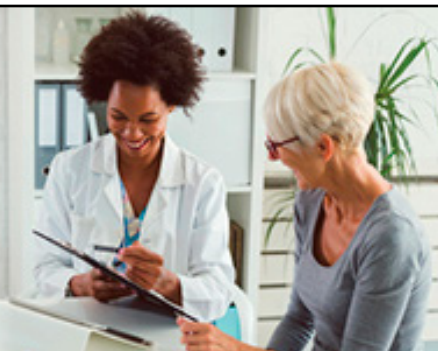
